# Secretary's report:

#### **OLD BUSINESS:**

Discussion about property 114 Palo Verde. The board agreed to give owner additional 30 days, (60 days to 90 days), to pay fine and move structure on property. Original date of notification of violation was March 11, 2020 with 60 days to comply, May 11, 2020. The due date will be moved from May 11, 2020 to June 11, 2020. Property owner stills need to pay the fine of \$1,000 and will be given the opportunity to pay in payments of \$333.34 due immediately, \$333.33 due May 11, 2020 and the remainder of \$333.33 on June 11, 2020 and the property owner must start taking structure down.
